HOSPICE DIRECTOR'S ANNUAL REPORT by Charlene Thurston, RN, ANP

The past year has been a year of extending Hospice's support into broader areas of the health care arena, while, at the same time, continuing to improve our care to the terminally ill. Since a fundamental part of our mission at Hospice Care of Nantucket has always been to improve general health care services available for all patients/families, we have undertaken several initiatives over the past year, in addition to offering our traditional range of hospice services. As we move towards broadening our role in palliative care services, we've provided direct care and counseling to several patients/families with long term, chronic (not terminal) illnesses. We've facilitated several discussions with other island organizations so that together we might consider the needs of persons and family caregivers of persons with Alzheimer's Disease. Following that same path, we have also begun an effort to consider the needs of persons and family caregivers of persons with other chronic illnesses. Lastly, while not a new initiative, we have continued to focus on improving pain management throughout the community, along with staff of the hospital and Our Island Home.

In order to increase public awareness and education about end of life matters. we've offered a variety of opportunities. Last fall, we joined with other community groups in planning and sponsoring the very successful Health & Spirituality Conference with Thomas Moore on "Care of the Soul," and will do so again this fall when the topic will be, "Raising Children to Feel Valued, and to Develop Values." In October, the Foundation hosted a community performance of the Pulitzer Prize winning play, "W;t," performed by local actors of the Theatre Workshop. tations on Advance Directives, and followed that up by writing an article on advance directives for our Hospice Newsletter, *Currents*. And, through the Nancy Adam Hospice Education Fund, we've donated a collection of over 35 books to the Saltmarsh Senior Center, so that materials might be available for loan there, as well as at the Nantucket Atheneum.

An exciting project, to which Andrea and I have dedicated a significant amount of time, has been the development of a website, hospiceofnantucket.org, which is now online. Our purpose in creating this site has been to broaden our efforts in education and support for Nantucket residents. In order to accomplish that, we've developed a fairly extensive website, with reprints of articles which we've written for our newsletters over the years, as well as links to other websites covering a wide range of topics related to hospice, supportive, and palliative care.

Over the past year, we've also continued our commitment to providing educational opportunities for professional staff of the island, and will continue to do so over the coming year, beginning with a presentation by Dr. Patrick Clary for hospital and Island Home health care professionals on the management of intractable pain.

The tragedy of September 11 has, of course, cast its shadow on everything and everyone over the past year. Since dealing with loss, death and grief is at the center of our mission, hospices were in the overlapping roles of being victimized by the tragedy, along with all other citizens of our nation, while also being observers of how the people of our communities were coping, and participants, with other organizations, in safeguarding our communities from the emotional trauma of this event. As churches arranged prayer services, schools mobilized to help students, and counseling services offered support, we, at HCON, tried to monitor how grief was unfolding in the community, provided education to help people understand the process of grief as well as when and how to seek help, offered support to our staff and the general public, and invited the community to commemorate further in our Tree of Remembrance Service during the holiday period.

All in all, our community seems to have done quite well through the year, though we'll all be affected forever by this event. One result of this tragedy was that it made most of us aware of how devastating loss could be for those who've lost a loved one - how vulnerable and ungrounded one could feel - and how much people need one another for support. *Continued on page 2*

"This job has been challenging, interesting, and I have enjoyed getting to know my co-workers, as well as the patients and their families," said Andrea. "However, I feel very good about leaving the job in the hands of such a well qualified person as Ginnie Faria. She has been a longtime valued volunteer and knows the program intimately." We feel lucky to be able to find such knowledgeable and committed people to help us serve the Nantucket community.

Help for Caregivers

One of our goals in Hospice is to collaborate with other community organizations to meet the needs of care givers. Our first project emerged from the PBS special "... and Thou Shalt Honor", which aired on October 9, with a forum for families the following week on October 16.

Members of the community and health and human service organizations attended the forum hosted by Hospice. The group was able to identify many of the needs of families and some of the gaps in services, as well as to begin to plan the improvement of the delivery of services to caregivers. Hospice and other agencies plan to formalize these discussions and to continue the dialogue with caregivers concerning their issues, needs, and concerns. Some of the needs that came out of the forum included:

- supplemental assistance for personal care at home
- an expanded schedule for adult day care
- outreach to caregivers about existing services
- decreasing the isolation of caregivers
- a telephone support network & support groups
- centralized resources for caregivers

- more respite breaks through volunteers & paid caregivers

The PBS special grew out of personal experiences of the program's producers, with an intention to raise awareness and give support and concrete information to

those faced with the overwhelming role of caregiver to a loved one. The producers' goals were to portray the true life experiences of caregivers, tell about the services and resources that are out there, convince caregivers that they are not alone, and to create audience awareness of their potential role.

The real-life stories portrayed the details and struggles of the daily lives of caregivers and their families; the importance of asking for help and cooperation from siblings; of planning and scheduling respite; and utilizing the resources within the community. The broadcast highlighted programs that work such as: Adult Day Care centers; Arizona's Altec program, where a family member may be trained as a paid professional; the Eden Alternative, a nursing home alternative that focuses on adding a lively atmosphere of plants, animals, and children; and OnLok, a program of all-inclusive care for the elderly in San Fransisco.

This is a big issue and one that few of us can avoid, for almost all of us will be caregivers someday. Perhaps two of the messages taken from the broadcast should guide us: "You can't go wrong if you honor somebody" and, "How a community cares for its elders is a reflection of how it thinks of itself."

Educational Opportunities for Health Care Professionals

Offering education in end-of-life care for island health & human service professionals has always been an important goal for Hospice, and, over the past year, several types of opportunities were offered and well received. All told, over 30 health care providers from the hospital, home health program, and Our Island Home, in addition to Hospice staff and volunteers, participated in a variety of programs, both on and off the island, with several attending more than one.

In September, we began our new fiscal year by inviting Dr. Patrick Clary, Medical Director of Seacoast Hospice in Exeter, N.H., to be both our Annual Meeting Guest Speaker, and a guest educator for medical & nursing staffs on the following day. His presentation on the "Management of Intractable Pain," was attended by over 25 staff members. Dr. Clary is certified as an educator for physicians in end-of-life care, and his presentation was very helpful in addressing the needs of patients in pain.
